Picnic Code of Conduct

We welcome you to come enjoy our lovely patio at the Wente Vineyards Estate Tasting Room.

Here are a few gentle reminders as you enjoy your stay:

- The patio is open during Tasting Room hours of 11am - 5pm.
- Outside food is welcome Monday- Thursday from 11-3pm. No outside food permitted Friday-Sunday and during special events
- Outside catering, barbeques, delivered food, large hors d'oeuvre arrangements, passed appetizers, large coolers, etc. are not allowed on property
- *Picnicking on the grass is not allowed*, including lawn chairs, blankets, mats, furniture, etc. However, all guests are welcome to picnic on the picnic tables, which are available by prior reservation for a rental fee of \$50 (first table) and \$25 (additional table.)
- If picnic tables have not been reserved, they may be enjoyed day-of visit on a first come, first served basis. .
- Out of consideration for all guests, picnic tables are available for a **maximum of two hours**.
- Outside food is not allowed in The Nth Degree Lounge.
- Consumption of alcohol anywhere on the premises is limited to those who can prove they are 21 years or older. *Valid identification is required.*
- No outside alcohol is permitted on the grounds under **ANY** circumstances. Outside alcohol is defined as any alcoholic beverage not purchased directly through or provided by Wente Vineyards.
- This includes gifts, favors, etc. that are brought onto property.
- These are not allowed on the grounds and must be kept in your vehicle.
- No tents, shade covers, large ice chests, or excessive decor are allowed.
- Small ice chests/coolers are permitted, however are subject to search.
- Smoking is only permitted in designated smoking areas.
- Wente Vineyards does not allow any elaborate decorations, including balloons, banners, BBQ's, podiums, and/or speakers for table reservations.
- Children must be closely supervised at all times.
- No throwing, tossing, or catching of any athletic gear and/or toys allowed in property. This includes but is not limited to Frisbees, baseballs, "cornhole/Baggo" (bean bag toss), footballs, tennis balls, etc.
- Pets are allowed only in the outside areas of the winery and must be on leash. Pet owners are responsible for cleaning up after their pets.
- Service animals are welcome in all guest areas; however, pets are not allowed inside the Tasting Room or Barrel Room.
- All guests are required to adhere to all safety rules and requirements.
- We reserve the right to refuse service to anyone and/or to remove guests who are disruptive or disorderly.
- It is our pleasure to provide you with glassware during your visit to The Wente Estate tasting room. Please return it to a staff member or leave it in a designated area when you are finished.
